**HOW IT  
WORKS:**

REDIRECTING YOUR TAX DOLLARS FOR THE GOOD OF CHILDREN - The original tax credit law allows Arizona taxpayers to make a contribution to a School Tuition Organization, like PAPPAS KIDS, that will help fund private school student tuition. You, the taxpayer, choose where to make the donation, not the government. This allows YOUR money to be used to give underprivileged students an opportunity to attend private schools in Arizona. When you contribute, you are making a donation. The state of Arizona will grant you a tax credit in return for that donation when you file your tax return.

**IMPORTANT:** If the taxpayer has actual Arizona state income tax less than the maximum donation amount allowable, the available credit in a given year is limited to the taxpayer's actual tax. The tax law allows a carry forward for up to five years if a donation is made in excess of the actual state income tax due.

**Deadline:** The deadline for private school tax credit donations is no longer December 31. Donations can be mailed or submitted online to PAPPAS KIDS prior to filing taxes, but no later than April 15 and still be eligible for the tax credit for the previous tax year. If your donation is made between January 1 and April 15, you can determine which tax year to claim the credit. It must be postmarked or submitted online by midnight on April 15 - there are no extensions!

**Receipts:** An annual tax statement is sent by January 31 of the following year. Use forms 323 (Original tax credit) 348 (Overflow tax credit) and 301 (to summarize multiple tax credits) to claim the credit on your Arizona taxes.

# Our MISSION



The Pappas Kids Schoolhouse Foundation helps low-income, homeless and at-risk youth in Arizona schools succeed and grow in a positive educational environment. We work with their academic, extra-curricular and personal needs. A School tuition organization cannot award, restrict or reserve scholarships solely on the basis of recommendation.

A taxpayer may not claim a tax credit if the taxpayer agrees to swap donation with another taxpayer to benefit either taxpayer's own dependent.

To date, the Pappas Schoolhouse Foundation has awarded more than 7,700 scholarships amounting over \$15.5 million dollars for students to attend private schools throughout Arizona. These students have gone above and beyond with their academic efforts to ensure they take advantage of the opportunity being provided to them. We have had many students advance from our scholarships program and receive college scholarships. Pappas Kids Schoolhouse Foundation remains focused on creating an effective learning experience for these

children by providing school necessities such as backpacks, calculators, school supplies, even computers when necessary.

Our goal is to promote lifelong learning with our students that will encourage them to stay in school. If we can encourage them to get an education, they will be able to support themselves in the future. This will help break the cycle of poverty that most of them currently live in.
