Did you know?

Arizona Private School Tuition Tax Credit Law, A.R.S. Section 43-1089 allows individuals to redirect their state income tax to school tuition organizations that provide scholarships to private-school students in Arizona.

Here's how it works.

One of the unique aspects of our program is that donors have full control over how their state tax dollars are spent. This means that underprivileged children are given the opportunity to receive a quality private education at the school of their choice. Your control and involvement in this process are crucial and empowering.

- Individual taxpayers are allowed an annual credit of up to **\$1,459**
- Married taxpayers filing separately can donate up to **\$1,459** individually
- Married couples filing jointly are allowed an annual credit of up to **\$2,910**

To claim the Overflow/PLUS tax credit, donors must first meet the maximum of **\$731 (single) or \$1,459(married) Original Tax Credit Program.**

By simply taking part, individuals will reduce the amount of money they owe to the State or increase the amount of their refund, dollar-for-dollar. Please note that this contribution may be eligible for a federal deduction. Consult your personal tax advisor on this matter.

We are deeply grateful for your support and for sharing our belief that all children deserve the right to choose their educational path. Your generosity is not just a financial contribution, but a vote of confidence in our mission. Thank you for being a part of this journey.

Contribution Deadline: **April 15th, 2025**. Pappas Kids Schoolhouse Foundation is a state of Arizona qualified Student Tuition Organization permitted to receive these tax credit contributions and award scholarships to economically disadvantaged students.
