This is a donation, not a deduction—Arizona will grant you a dollar-for-dollar tax credit when you file your state tax return.

Arizona Private School Tax Credit - Key Information

- Tax Credit Limit: If your Arizona state income tax is less than the maximum allowable donation, your credit is limited to your actual tax. Excess donations can be carried forward for up to five years.
- Donation Deadline: The deadline is April 15 (not December 31). Donations to PAPPAS KIDS must be mailed or submitted online before filing taxes and no later than midnight on April 15 to qualify for the previous tax year.
- Choosing Your Tax Year: Donations made between January 1 and April 15 can be applied to either the prior or current tax year. No extensions are allowed.
- Receipts & Forms: Annual tax statements are sent by January 31. Use Form 323 (Original Credit), Form 348 (Overflow Credit), and Form 301 (Summary) to claim your credit.
